Governor DeSantis Issues Statewide Safer-at-Home Order Construction Deemed Essential

Governor DeSantis just publicly announced that he is issuing a statewide "Safer at Home" order. This order will be in place for 30 days.

Important to note - the order allows for essential businesses to continue functioning and defines construction as an essential business. It does this in a number of ways.

1. Executive Order 20-91 utilizes the U.S.. Department of Homeland Security's Advisory Memorandum on services deemed essential. The CISA doctrine, as it is now referred, specifically designates construction as essential.
2. Executive Order 20-91 also includes, by reference, Miami-Dade County's Emergency Order 7-20, and it's list of essential businesses. Miami-Dade County's Emergency Order 7-20, also included as part of the attachment, states that contractors and tradesmen are essential AND that open construction projects, regardless of type, are essential. Miami-Dade County's Emergency Order 7-20 was adopted as policy in Governor DeSantis' previous regional "Safer at Home" emergency order that applied to Monroe, Miami-Dade, Broward and Palm Beach Counties.
